√ 2013 Congress of Neighborhood Councils set

Neighborhood Council leaders from throughout the City of LA partnered with the Department of Neighborhood Empowerment (EmpowerLA) to bring the 2013 LA Congress of Neighborhoods to City Hall on Saturday, September 28, from 7:45 a.m. to 4:00 p.m. The free event includes breakfast and lunch, workshops, networking and the opportunity to connect with local and state leadership as well as the city departments that deliver city services.

✓ OK to park at broken parking meters again

The Los Angeles City Council overturned a policy that allowed vehicles parked at broken or inoperable parking meters to be ticketed. The original policy was intended to discourage drivers from vandalizing meters in order to park free. The City Council will revisit the decision in six months to see if vandalism has increased.

√ Councilmember Huizar Chair of PLUM

Councilmember lose Huizar of CD 14, was named Chairberson of the City's Planning and Land Use Management Committee (PLUM). The powerful committee is highly influential on matters such as hillside development.

√ Cost goes up for freeway tunnel repairs

The estimated cost of repairs to the tunnel connecting the northbound 2 freeway to the northbound 5 freeway has increased to \$16.5 million according to Caltrans. Damage was caused by a tanker truck that caught fire in the tunnel on July 13th. Caltrans will need to repair walls, columns, outrigger beams and pavement. The tunnel is scheduled to reopen by Christmas.

√ Parkway edible gardening gets a reprieve

Councilmember Herb Wesson has introduced a motion that would allow planting residential parkways with food crops, but processing of the motion is going slowly. In the meantime, Mayor Garcetti and the City Council have suspended enforcement of the current prohibition until a report is presented to the Council.

√ Free spay/neuter for homeless/feral cats

√ Aquacise in new schedule at Glassell Park pool

Water exercise classes are offered at the GP pool on Monday & Wednesday evenings at 6pm. The new pool schedule is: 6-8am lap swim, 1-6pm recreation swim (several lanes for lap swim), 6-7pm lap swim.

√ Citrus quarantine

Agriculture officials imposed quarantines in nine California counties including Los Angeles, restricting the transport of citrus trees after the Asian psyllid was found. The psyllids are still multiplying, however, so experts are going door-to-door, getting permissions, then releasing tiny parasitic wasps that feed exclusively on psyllids.

Councilmember Cedillo re-appropriates Reyes's LA River funds

The City Council approved Councilmember Gil Cedillo's motion to shift \$500,000 that was just recently appropriated by former Councilmember Ed Reyes for Los Angeles River related projects to a fund that will be used to "address community needs in Council District One".

In a statement supporting the motion, Mr. Cedillo's office said, "Council District One has identified alternate community priorities for these funds." The Councilmember will complete his "listening tour" before providing details about how the funds will be used.

Army Corps of Engineers study of L.A. River due at last

On September 20th, the U.S. Army Corps of Engineers is expected to release a long-delayed feasibility study focussing on an 11 mile length of the Los Angeles River stretching between Union Station and Griffith Park. Three alternatives aimed at restoring the river's ecosystem and easing access to the river's banks are being considered.

The cheapest option, at \$444 million, Alternative 13 calls for concrete removal and ecological restoration at several key sites including the Taylor Yard complex on the east side of the river near Glassell Park.

Alternative 16, with an estimated price tag of \$774 million, would widen the river to accommodate terracing on much of its eastern bank (from roughly Los Feliz Boulevard downstream to Fletcher Drive) and redevelop the so-called Piggyback Yard, a site that is owned by Union Pacific Railroad and covers 125 acres across the river from Union Station.

Endorsed by the City Council, Alternative 20, at \$1.06 billion, would, in addition to those changes, provide new connections to the L.A. State Historic Park near Chinatown, and fund substantial ecosystem restoration where the river meets a tributary near the border of L.A. and Glendale.

For the cheapest, Alternative 13, the city would have to bear more than 70% of the total cost, including land value. Each of the other options would come with more federal money, closer to a 50-50 split.

A 45-day period of public comment will follow, giving river advocates and city officials a chance to argue for the more expansive vision of Alternative 20, if that is not selected.

Councilmember Jose Huizar accused of harassment



A complaint was filed against Councilmember Jose Huizar and the City of Los Angeles by Mr. Huizar's former Deputy Chief of Staff, Francine Godoy. In her complaint, Ms. Godoy, who left the Council office four months ago, said she experienced discrimination, harassment and retaliation because of her gender and her refusal to "engage in sex". The complaint also alleges that Ms. Godoy was denied a promotion, forced to quit, and hindered in her ability to run for office.

City Council President Herb Wesson has instructed the city's Personnel Department to assemble the Special Committee on Investigative Oversight to look into the misconduct complaint.

Rick Coca, a spokesperson for Councilmember Huizar, said that the Councilmember "strongly and emphatically denies the assertions made in the claim sent to the city and intends to fully cooperate with the city in any investigation of this matter."

City Attorney Mike Feuer backs neighborhood prosecutors

City Attorney Mike Feuer says he wants to revitalize the neighborhood prosecutor program in which members of his office would work with community members to identify problems where use of the law could help.

Dear Neighbors,

The end of the Legislative session is approaching and as Chair of the Senate Appropriations Committee I'm focused on analyzing which legislation is fiscally prudent for the state during our economic recovery.

Since last year's passage of my Senate Bill 1201, which made the LA River more accessible for recreational and educational purposes, the health and revitalization of the river has continued to be a major priority for my office. We're currently involved in discussions between Metrolink, community members, and other elected officials, regarding health concerns from exposure to diesel exhaust and other particulate matter. Metrolink has responded to these concerns by commissioning a Health Risk Assessment (HRA) of the "Taylor Yard" Central Maintenance Facility. I have been convening all the parties involved to review the scope of work of the HRA and to give input on the methodology, implementation and parameters so that we can further develop and foster a great river community in Northeast L.A.

Recess in the district came to an end, and just as students returned to school, I've returned to the legislative session.

The Legislature reconvened on August 5th, and since then, I have been reviewing and voting on as many as 200 bills a day. And as these bills make it to Governor Brown's desk, I am proud to share that the Governor has signed AB 238, which I authored in an effort to give law enforcement tools to fight domestic violence in our communities. AB 238 will ensure that all Emergency Protective Orders (EPO's) are entered into the California Restraining and Protection Order System, electronically. Having EPO's in this database will give officers the ability to act more quickly and prevent domestic violence.

In the district, my team is busy with preparations for our upcoming Health Fair in East LA (Sept. 21st) and Northeast LA (Oct. 19th). Please join me and the 70 service providers who will be waiting for you! I want to make sure you get access to critical information on how the Affordable Care Act, through Covered CA, will impact you and your family. Join us for free: vision screenings, dental screenings, medical checkups, dental kits, nutritional information, and more.

Cell tower/Community marker

The much discussed and long-awaited Verizon cell tower alongside the San Fernando Road offramp of the northbound 2 Freeway is complete. Though the new community marker is an example of what a little creativity and a lot of community input can achieve; at this location, an undisguised cell tower would have been almost unnoticeable. It's just as well that there is no clock on it, since the structure is mostly hidden from the freeway by large trees, and is almost invisible from surrounding streets. The modified Art Deco design successfully disguises the cell tower, butunless there is a tree-trimming and the promised "up lighting" materializes--does nothing to welcome visitors to Glassell Park.



Verdugo Rancho Market

The Verdugo Rancho Market on the corner of Verdugo Road and Arthur Street, burned almost completely on August 4th. Luckily, the fire occurred after the market had closed for the day, and no one was injured in the blaze.

The Los Angeles Fire Department has completed its investigation, and says the cause of the fire is "undetermined, most probably accidental". An LAFD investigator said they have ruled out arson.

The owner intends to rebuild the market.

Glassell Park Elementary School needs new flags

The U.S. and California state flags located near the corner of Cazador Street and Cypress Road on the Glassell Park Elementary School campus are faded and very tattered. GPIA Board member and U.S. Navy Veteran, Mark Quiroz, will spearhead the effort to obtain new flags and provide the school's staff and students with guidance on flag-related protocols.





Councilmember Cedillo backs Southwest Museum

After speaking with community members from Mt. Washington on the first stop of his "Listening Tour", and hearing the results of their discussion groups, Councilmember Gil Cedillo found that the restoration and reopening of the Southwest Museum is the area's most important issue.

The meeting's results were summarized in an e-Letter from the Councilmember's office: "Residents would like to see the gem in CD1 open and accessible to the community once again. Councilmember Cedillo ensured [sic] attendees that he understood the importance of the museum to Mt.

Washington and the surrounding communities, and asked for their patience as

this battle will not be won overnight. Nonetheless, it's a battle he is willing and ready to wage."

Councilmember O'Farrell calls for Van de Kamps transition

Councilmember Mitch O'Farrell sent a letter to the Los Angeles City College District Board of Trustees urging them to work with his office and the community to facilitate a transition of the Van de Kamps campus from its "temporary leasing activity" to its intended purpose--"an innovative mix of community service courses, workforce training, and academic core courses". In his letter, Councilmember O'Farrell offered to help Alliance Charter School,

the current tenant, find a permanent location. The Van de Kamps Coalition encourages community members and leaders

to speak up in support of Councilmember O'Farrell's effort, and tell the Board of Trustees that we expect the community college bond funds that we approved to be spent in the way they were intended.

According to the builder, Warmington Residential, signage about the construction will be on the fences in early September.

The Los Angeles City Council voted 13-2 in favor of overturning a 10-year ban on murals within the city. Since the ordinance did not pass unanimously, a second vote will be required. The new ordinance would allow non-commercial murals to be created throughout the city. Councilmember Huizar, who sponsored the ordinance, pushed for support of a version of the ordinance that allowed murals on single-family homes, but that version did not pass. The Department of Cultural Affairs will consider a pilot program that would allow murals on single family homes in CDs 1 and 14. City officials will draft an opt-in process for neighborhoods to allow murals on homes.



Demolition ordinance proposed

Councilman Mitch O'Farrell, CD13, introduced a motion that would require public notice and feedback prior to property demolition. The motion states: "Demolition permits are issued without a public process. When a property owner decides to demolish an existing structure, it can significantly change the character of the surrounding community. There is no recourse for community stakeholders who are concerned about the character of their community because they do not have the opportunity to be involved in a public process prior to demolition."

The motion, if approved by the City Council, would require the Building and Safety Department to develop a public notification process--including the posting of signs 30 days before tear downs are scheduled to begin. In addition, fees would be charged to cover enforcement of any new regulations overseeing the demolition process.

Goodwill to bring multi-use facility to K-Mart site

Goodwill of Southern California will create a Community Enrichment Center at the long-vacant K-Mart building on San Fernando Road near Fletcher Drive. In a statement, Goodwill said that at the Center, "individuals with disabilities and disadvantages will access free career counseling and placement services, employment preparation courses, and educational and technical skills classes". Residents and businesses will be able to donate unwanted items and utilize services such as e-waste recycling, secure shredding and document imaging. There will be a retail store and clearance center, and a training café for dining. Community organizations and government agencies will be welcome to utilize the facility for meetings and events."



Walnut Canyon

Walnut Canyon is one of the largest open spaces in Northeast Los Angeles. The 32 acres of hillside land in Glassell Park is mostly grassland and California Black Walnut woodlands, and is home to abundant wildlife including hawks, owls, various migratory birds as well as raccoons, skunks and coyotes.

It has been a longtime goal of the GPIA to protect and preserve Walnut Canyon as a natural wildlife habitat for all to enjoy. It's time to try again!

The benefits of green space cannot be exaggerated--even residents who never visit will breathe cleaner air from the oxygen-producing plant life. In the case of

Walnut Canyon, the benefits to the community are many: hiking trails, bird-watching, nature study, open space within the city. The preserve would also provide a wildlife corridor linking other preserved areas.

Please call upon State Senator Kevin deLeón, Assemblymember Jimmy Gomez, County Supervisor Gloria Molina, Mayor Eric Garcetti and our Councilmembers to energetically support the acquisition of Walnut Canyon as public open space.

As promised in the July issue, here are some options for sit-down Mexican/Central American dining in GP:

La Esquina Restaurant & Meat Market

Breakfast, lunch, dinner Parking lot, credit cards OK 4159 Eagle Rock Blvd (at Av 42) 323-474-6050 3301 Division St (at Av 33) 323-221-1571

At the corner of Avenue 33 and Division, in what was a neighborhood corner drug store in days of yore, is La Esquina. La Esquina is the corner restaurant and market every neighborhood in Los Angeles might want, and Glassell Park's got it. Open early and until 7pm, it is the ideal place to run out to when you need to grab a last minute onion for a recipe you're making, marinated carne asada to throw on the grill for last minute guests, a quick cup of cafe de olla, a tasty pupusa smothered in a spicy, tangy, crunchy curtido (just a \$1.25!), a cold horchata, or a \$4.50 veggie burrito (which always includes avocado at no extra charge). La Esquina specializes in Salvadorean and Mexican food. Other dishes include platanos fritos con crema, breakfast burritos, daily specials including soups, and an occasional Friday night taco grill in the summer which brings out the neighborhood for \$1 tacos.

A friend visiting from NYC enjoyed the tortas and huevos rancheros in the mornings along with cafe de olla while she stayed with me, and picking up mineral water on our walks in the neighborhood with my dog. Check out the menu outside and then place your order inside from store owner Miguel at the register, who gives you a ticket and passes your order off to the kitchen. Then show your ticket to the women at the window, grab a seat at one of the outdoor tables for two, take some time to look around at picturesque Mt. Washington above you, and people watch as the neighborhood goes by and others from all walks of life enjoy their food. La Esquina has been in the neighborhood for over 20 years, and for good reason. Addendum: A new sit-down location also exists at the corner of Eagle Rock Blvd and Avenue 42, across the street from Fresh and Easy.
